6. Financial Reports	a. Financial Report, Stockholm 2016	Magnus Hammar and Barbara	
App. 2a,2b	Magnus reported on the financial result for 2016. IUT had slightly less income for 2016, compared with 2015, due to less		
App. 3	payment by board members.		
App. 4	Cost for board meetings exceed the budgeted €3,000 and ended at €4,214, mainly due to higher costs than expected for the board meeting in Zurich, May 20-21. We have also have slightly higher costs for member organisations, due to higher		

travel costs. We had less costs for the IUT congress than anticipated, €28,455 – compared to the budgeted €40,000. Due to TPAS Scotland's good connection with the Scottish government and also thanks to many other sponsors. All in all, for the regular budget 2016 we had budgeted negatively at - €30,419, but ended up at only - €9,345.

b. Financial Report, Brussels 2016

For Brussels, CNL did not pay the contribution. There were less costs related to "consultancy work for members", as CNL prematurely cancelled the contract with Davide Lanzillotti, only $\[\in \]$ 316 instead of $\[\in \]$ 6,500.

Costs related to ERHIN only ended at €499, instead of the budgeted €5,000.

Brussels office ended up with a surplus of €19,621.

c. Paid membership fees, board Stockholm & Brussels

The head office in Stockholm are missing payments from CNL, France. CNL reports that they have made the payment last Friday, so it should be on its way.

The Brussels office are missing payments from SON, Czech Republic and CNL, France. Lenka Tarabova (SON) will look into the missing Czech payment.

Decision:

The board decided to adopt the IUT Financial Report, 2016.

7. CNL membership fee Stockholm & Brussels

On January 26, 2017, the IUT Secretariat/Sven Bergenstråhle received a letter from Eddie Jacquemart, expressing CNL's difficulties of paying the annual regular fee of €5215.

Eddie Jacquemart suggested that CNLs' annual fee would be €2000 from 2017.

Eddie explained why CNL needs to cut down on the IUT fee. The CNL has got a lot of financial difficulties at the moment, they are also going to sell parts of their head office in Paris due to this. The CNL are also seeing a decrease of members and therefore incomes to fund the organisation.

Concerning the payment for IUTs Brussels office, Eddie proposed €150 as a symbolic contribution to the Brussels office.

A discussion followed about the total distribution of fees and also the criteria for that distribution. The discussion concluded in a SUT proposal; to establish a working group to look into the fees and contributions of each organisation.

It would also be a natural consequence to follow up on the

work of establishing new Statues and Governance Structure.

The suggested members of the group are: Germany, Sweden, France, Denmark, Finland. Sven

Decision:

The board decided in line with the Secretariats proposal to agree with the proposal from CNL. But CNLs' lower fee is for one year, and will be discussed again at the spring board meeting in 2018.

The board also adopted the SUT proposal to establish a working group on IUTs' fees.

8. New IUT Statues

In line with decisions on the last board meeting and the IUT Congress in Glasgow, the Working Group on Statutes had produced a proposal for new IUT statues. The proposal was sent out on January 2 for consultation to all IUT board Members and paying (€60) Members.

Replies/comments were received from SICET, Italy and from TQ, Australia, with some minor proposals, which has been taken into account. The Working Group had therefore sent out an updated proposal which was presented to the board.

Decision:

The board decided to adopt the proposal for new IUT statutes, valid from today, April 27 2017.

9. IUT Governance Structure

Magnus presented the proposal for a new Governance Structure of the IUT which was decided on at the last Board meeting in Glasgow, 13 October 2016. The intention was then to activate this new structure as the new statues came into place.

Decision:

The board decided that the IUT Governance Structure will be valid from today, April 27 2017.

10. Status about new Secretary General

Magnus Hammar informed that he will end his work with IUT on June 23, after working for IUT for 18 years.

The job advert for a new SG was posted on April 7, by the Swedish Union of Tenants, SUT. Magnus explained that the advert was delayed partly due to the fact that the headquarters of the Swedish Union of Tenants, with some 70 staff members

incl. IUT staff, was re-organised on April 3, and all new posi-

tions were on hold until then.

New head of IUT responsible department at SUT is Gunilla Thorin. Gunilla said that so far there is 16 applicants, but the application time has not finished yet (May 30). As soon as the deadline is out the SUT will review the applications and start interviews. In this process, the IUT President will also be given an influence.

Concerning the IUT Assistant Secretary, talks are being held between IUT (SB) and the Swedish Union of Tenants.

b) EU Urban agenda & Housing partnership

Barbara informed about the EU Urban agenda & Housing partnership. It is now part of a coming inter institutional negotiation, and therefore the Brussels office will be watching the developments. Barbara also encouraged the member organisations to do the same.

c) European Pillar of social rights

The pillar of social rights is valid for the Eurozone member states. All other are invited to opt in (it is not clear if SE, DK, CZ will do this)

Barbara introduced the keynote speaker Ms. Raquel Cortes-Herrera, Deputy Head of Unit, DG Employment and Social Affairs, European Commission (EC). For full notes on the talk, see the appendix to the protocol.

From the discussions, the board agreed on Barbara's proposal to decide on proposing amendments and changes to the Commission Proposal for an interinstitutional proclamation endorsing the European Pillar of Social Rights, point 19. The proposals will be put forward in our continued lobbying efforts. The board decided to propose the following formulation (changes marked in red):

- 19. Housing and assistance for the homeless
- a. Everyone lacking sufficient resources shall be provided with access to affordable and social housing and/or housing assistance of good quality.
- b. Everyone has the right to appropriate assistance and protection against forced eviction.
- c. Adequate shelter and services shall be provided to the homeless in order to promote their social inclusion.
- d) EU clean energy package

This law would be an improvement to the housing situation. It looks though as if the new law will be on hold until after the upcoming elections, which might be won by opposition parties, that oppose the law. Right now the Czech tenant union is watching the situation closely.

Eddie informed about the coming French elections where there is a large degree of uncertainty about both candidates' stances on the housing situation. Also in France, there is a large degree of uncertainty at the moment.
